At a meeting of brothers of Short Horn Battle held at the Hospital in Madison, Wisconsin, evening February 4th - 1883, for the purpose of organizing a State Association. The following code of By-Laws was presented by George Harding of Waukesha, Wis, and adopted by gentlemen present. Was out-lining the object of the Association, and the manner of conducting the affairs of the same.

By-Laws.

- Art. 1. This organization shall be known as the Wisconsin Short Horn Brothers' Association.
- Art. 2. Its object shall be to promote the interests of Brothers of Short Horn Battle within the State.
- Art. 3. Any reputable brother, or other person interested, may become a member of this Association by paying a fee of one dollar, and having his name entered upon the roll of membership by the Secretary.
Any member, who may be found guilty of any unlawful or dishonorable conduct in his business as a brother, may be expelled at any Annual Meeting, by a three-fourths vote of the members present.
- Art. 4. The Annual dues of this Association shall be fifty cents and no member in arrears for dues or membership shall be entitled to vote, but ~~shall~~ ^{equal} annual dues may at any Annual Meeting be omitted by a two-thirds vote.
- Art. 5. The Officers of the Association shall consist of a President two Vice Presidents, a Secretary and Treasurer, and two other members, who with the Officers heretofore enumerated shall constitute the Executive Board of the Association.

Art. 6. The officers of the Association, shall be chosen at the Annual meeting. For a term of one year, and shall continue in office until their successors are elected.

Art. 7. The President shall preside at all meetings of the Association. The Vice Presidents may preside at meetings of the Association in the absence of the President.

The Secretary and Treasurer, shall keep a correct record of all meetings of the Association, and the Executive Board, conduct the correspondence thereof, receive all money due such organization, have charge of the funds and pay such bills as may be approved by the Executive Board.

He shall at each annual meeting submit a ^{financial} report giving a detailed statement of all receipts and disbursements for the past year, and the financial standing of the Association at that time.

The Executive Board shall have full management of the business affairs of the Association.

Art. 8. The Annual meeting of the Association shall be held ^{on} Wednesday evening of the week of the State Fair, at the place where such Fair may be held, under such arrangements as may be determined by the Executive Board.

An adjourned meeting will be held each year, at Madison Wis. during the time of the State Agricultural Convention, for the discussion of matters pertaining to the interests of the Association.

Art. 9. These By-laws may be amended at any annual meeting, by a two-thirds vote of members present.
